

Cibo Bambino - Fiat 500 Competition 2011/12

Terms and Conditions

2. Entry is open to residents of South Australia and Queensland who have access to the internet in order to submit an entry (Eligible Entrant). Employees of the promoter, the promoters associated companies and their immediate families are ineligible to enter the competition

To enter the competition the prize draw, purchase any products to the value of five dollars or more from a participating Cibo Espresso Store where the promotion is advertised and you will receive an entry form with a code.
